4) I understand and accept MCP reserves the right to refuse my, or minor(s) listed below, entrance to their property, or performance of services, based on the above stated policy. I understand and accept MCP reserves the right to excuse me, and/or any minor(s) listed below, as a volunteer without explanation, if I, or minor(s) listed below, violate MCP policies and regulations during my time volunteering at any MCP event or on MCP property.

5) My signature below indicates that I have read and agree, without dispute, to MCP policies and regulations for volunteers. As a condition of participation in these activities, on behalf of myself, and my successors and assigns, I hereby agree to forever release, discharge, acquit, hold harmless and indemnify, MCP, their affiliates and their respective members, partners, principals, shareholders, board of governors, officers, agents, employees, volunteers, and representatives (including, without limitation, any landowner, landlord, land manager or tenant who grants access to any property for purposes related to the MCP, and their respective successors and assigns ("Released Parties"), from any and all charges, complaints, claims, demands, obligations, damages, actions, causes of action, suits, rights, costs, losses, debts expenses (including attorney's fees and costs) liabilities, and indebtedness, of every type, kind, nature, description or character, whether known or unknown, suspected or unsuspected, liquidated or unliquidated arising from, under, or related to, any act or omission of any of the Released Parties, or otherwise in any way related to, or arising from, participation in the MCP ("Released Matters"). I acknowledge and agree that the releases made herein constitute final and complete releases of the Released Parties with respect to all Released Matters, and that by signing this Agreement below, I am forever forfeiting the right to sue or attempt to recover money, damages or any other relief from the Released Parties for all claims I may have with respect to the Released Matters (even if any such claim is unforeseen as of the date hereof.) I understand Colorado Code, which provides that preexisting circumstances may exist that the parties are unaware, and may waive any disclaimer enforcement. I, being aware of this Code, hereby expressly waive any and all rights I may have there under such, and do so understanding and acknowledging the significance and consequence of such specific waiver.
